With reference to the Company's announcement made on 29 November 2017, whereby the Company has announced that the Company's subsidiary BTM Western Power Green Energy Sdn Bhd ("BTMWP"), has submitted its application and proposal to develop a Waste Incineration Power Plant Project located in the State of Melaka with capacity of not less than 1,000 tons ("the Project") to the relevant authority of the State Government of Melaka.

The Board of Directors of BTM Resources Berhad wishes to announce that on 2 January 2018 BTMWP has received a letter dated 20 December 2017 from the Unit Perancang Ekonomi Negeri Melaka informing that all projects relating to the solid waste management and public cleansing is under the executive power of the Federal Government through its Jabatan Pengurusan Sisa Pepejal Negara ("JPSPN") in line with Akta Pengurusan Sisa Pepejal dan Pembersihan Awam ("Akta 672") . In view of the above, BTMWP will submit its application of the Project to JPSPN in due course.
